

## YOUR RESPONSIBILITY TO APPEAR FOR THIS CITATION

### WHEN DO I NEED TO APPEAR?

Your response date appears on your citation just below your signature. You must respond **no later** than this date. It is the last day that is considered "on time" and will determine what options are available to you. To respond, choose one of the four options listed in this brochure.

TELEPHONE CALLS are for information only and are not considered an appearance. INABILITY TO PAY THE FINE IS NOT a reason for failing to appear.

### HOW SOON CAN I TAKE CARE OF MY CITATION?

The police department must first file the charge with the court, so we ask that you please wait at least 3 business days before calling or appearing.

### CONSEQUENCES OF IGNORING THIS CITATION:

Failure to take care of the charge will result in a warrant being issued for your arrest and your driver's license renewal will be denied.

### INSTRUCTIONS FOR JUVENILES (16 AND UNDER)

State law requires juveniles to appear before the judge WITH A PARENT or legal guardian for all court hearings. The court will notify you of your court date by mail to the address on the citation.

### INSTRUCTIONS FOR MINORS (17-20)

Minors charged with alcohol/tobacco/drug paraphernalia/theft or disorderly conduct must also appear before the judge. The court will notify you of your court date by mail to the address on the citation.

### **ALL FINES ARE SUBJECT TO CHANGE WITHOUT NOTICE**

**Speeding** = \$8.00 for each mile over the posted limit + \$134.00 (state mandated court costs)

**Speeding in School Zone** = \$10.00 for each mile over the posted limit + \$159.00 (state mandated court costs)

### POSSIBLE COMPLIANCE DISMISSALS

If your citation is for any of the following violations, your case may be eligible for a "fix-it" dismissal. Submit proof of compliance along with the dismissal fine noted.

Fail to Maintain Financial Responsibility	No Fine <i>(No Insurance – Must submit proof of auto insurance covering the driver or the auto in effect at the time of the stop.)</i>

### DISMISSAL FINE

## OPTION 3 REQUEST A DRIVING SAFETY COURSE

This option will result in a dismissal if you successfully complete the terms of the Driving Safety Course (DSC). The DSC is allowed for moving violations only.

#### ELIGIBILITY:

- You have a valid Texas Driver's License. Military personnel and their dependents may submit a copy of their state driver's license and military identification card.
- You have current liability insurance.
- You have not completed a DSC within the 12 months preceding the date of this citation.

#### NOT ELIGIBLE:

- You now hold/held a Commercial Driver's License when cited.
- The violation occurred in a construction zone with workers present.
- Charged with speeding 25 or more over the speed limit.
- Charged with passing a school bus.
- Charged with leaving the scene of an accident.

- Submit the notarized affidavit below. (Not required for walk-ins.)
- Court Costs of \$144.00 or \$169.00 (for school zone violations).
- Copy of your Texas driver's license and current proof of insurance listing you as a covered driver.

### A- DRIVING SAFETY COURSE REQUEST

I wish to enter a plea of No Contest, waive my right to a jury trial and request to take a Driving Safety Course. I understand that upon the Court's approval I will have 90 days to complete an approved course, and to present a certified copy of my driver record as maintained by the Department of Public Safety. My failure to comply will result in assessment of a fine and conviction on my driving record.

## OPTION 1 PLEAD NO CONTEST OR GUILTY & PAY IN FULL OR REQUEST A 30 DAY EXTENSION TO PAY

This option will result in a conviction and close the case.

### PLEA OPTIONS: **Choose your plea and complete all fields.**

(\_\_\_\_) I enter a plea of **Guilty** and waive my right to jury trial. *This selection means that you do not contest the State's charge(s) against you and admit guilt and agree to pay the fine/costs assessed by the Judge.*

## OPTION 2 PLEAD NOT GUILTY & REQUEST A TRIAL

## OPTION 4 REQUEST DEFERRED DISPOSITION

This option will result in a dismissal if you successfully complete the terms of the Deferred Disposition (DD). A DD is similar to probation. The general terms are listed below however, other conditions may be ordered at the discretion of the Judge. The deferrals listed below may be processed by the clerk, all others will require a court setting and must be requested from the Judge.

### MOVING TRAFFIC OFFENSE

Deferral Period: 120 Days Fees: Citation Fees + \$30.00  
Conditions: Submit copy of DL/Insurance with this request, commit no new traffic offenses, if under the age of 25 must also complete a driving safety course.

### NO DRIVER'S LICENSE

Deferral Period: 180 Days Fees: \$280.00  
Conditions: Obtain a valid driver's license, submit copy of DL/Insurance with this request, must maintain valid driver's license for entire deferral period.

### DRIVING WHILE LICENSE INVALID

Deferral Period: 180 Days Fees: \$355.00  
Conditions: Clear the hold/suspension on your driver's license. Submit copy of DL/Insurance with this request, must maintain a valid driver's license for entire deferral period.

### NO INSURANCE

Deferral Period: 180 Days Fees: \$350.00  
Conditions: Submit copy of DL/Insurance with this request, must maintain insurance for entire deferral period with no lapses.

### NO SEATBELT

Deferral Period: 90 Days Fees: \$175.00  
Conditions: Submit copy of DL/Insurance with this request, commit no new seatbelt offenses.

### PROHIBITED USE OF PORTABLE ELECTRONIC DEVICE

Deferral Period: 120 Days Fees: \$175.00  
Conditions: Submit copy of DL/Insurance with this request, commit no new electronic device offenses.

### POSSESSION OF DRUG PARAPHERNALIA

Deferral Period: 180 Days Fees: \$325.00  
Conditions: Complete 6 hours of community service, commit no new drug or alcohol offenses.

### NOT ELIGIBLE:

- You possess a Commercial Driver's License, and the violation is a moving violation.
- The violation occurred in a construction zone with workers present.
- Charged with speeding 25 or more over the speed limit.
- Charged with Passing a School Bus.
- Completed Deferred Disposition in the past 12 months.

1. Complete and submit this section.
2. Include a copy of your DL/Insurance if is listed as a condition.
3. Fees will be due in 30 days. The due date to pay will be noted on your deferral order.

### DEFERRED DISPOSITION REQUEST FORM

I wish to enter a plea of  Guilty  No Contest, waive my right to a jury trial and request Deferred Disposition. I do not hold a commercial driver's license and have not been granted deferred disposition within the past 12 months. I understand if my request is approved, I will be placed on probation for 90-180 days, and assessed a deferral fee which will be due within 30 days. In addition, I will also be required to appear at the end of the deferral period for a review hearing with the Judge. Other conditions such as completing the driving safety course or community service hours may be ordered at the discretion of the judge.
